- 1. **READ THE WILL**. Read the whole Will first. If you do not understand something, ask a lawyer to explain it to you.
- 2. INITIAL THE BOXES NEXT TO THE ITEMS YOU WISH TO CHOOSE.
- 3. **DATE AND SIGN THE WILL AND HAVE TWO WITNESSES SIGN IT**. Date and sign the Will at the end and have two witnesses sign it. The witnesses must be present when you sign the will.
- 4. **IDENTITY OF WITNESSES:** Your witnesses cannot be people who are receiving any of your property that you are bequeathing by this will.
- 5. **PLEASE NOTE:** You do NOT need to have this document notarized.
